



## 2019-Draft Owner Rules, Regulations and Fantasy Information

1. Owners must have line up in by every Friday at midnight CST to set up that week's match. Please email the lineup form with complete information to [tripsjr15@hotmail.com](mailto:tripsjr15@hotmail.com)  
NOTE: Owners that do NOT set their lineup and turn in before Friday at midnight will incur a \$50 fine. If you FAIL to set a lineup, your lineup goes back to the previous week's members playing.
2. D-Draft Owner Ed McCammack will put all lineups in and set the matches, he will NOT set Team Radikal. This is the team that Owner Jeff Mahan is overseeing. This is to maintain a secure and fair league. Ed will NOT post a match until both teams fill in their lineups.
3. League Dues for the 2019 Season from each member will be \$40 a month (\$20 a scheduled match). The members will send the \$40 each month to you the Owner. Once you collect the \$400 from each scheduled match, you will then send the total amount of \$400 via PayPal to [ddraft@adadarters.com](mailto:ddraft@adadarters.com)  
NOTE: Payments are due by the end of each scheduled match. Any payments not coming in on time or not totaling \$400; the Owner will get fined an additional \$50 for penalty.
4. Any team suspension, probation and/or penalty will be enforced by you, the Owner and information will be sent to the D-Draft Office and placed in the member's file. NOTE: The D-Draft Office will not overturn any ruling set forth by the Owner. If the D-Draft office issues a suspension or violation from league and/or tournament play, the owners will be notified with the penalty and occur a violation fee based on the infraction.
5. Trading D-Draft Pick's. Owners may trade member's between teams. Owner's must send the members on each team's complete information. There is a trade transaction of \$20 to the D-Draft Office. Submit the trade to [ddraft@adadarters.com](mailto:ddraft@adadarters.com) and send the \$20 via PP to the same email address.
6. D-Draft Team Shirts will go through the D-Draft Home Office as far as choosing the design and format. Owners will then decide if they would like their teams to obtain Team Shirts with their team colors. All D-Draft apparel, swag, items, products and merchandise will go through the D-Draft Home Office and profit sharing will be divided between the owners. More information coming soon on this.
7. The Owner of the winning team of the D-Draft Championship will automatically receive \$1000.
